With reference to the subject cited above, I am to say that MO-MBBS posted for 1 year Rural Posting under NRHM as per Office Memorandum No. HLB/400/2009/06 dated Dispur, the 28<sup>th</sup> August, 2009 and Notice No. HLB/400/2009/07 dtd 29<sup>th</sup> August, 2009, the following leaves will be entitled during their period of 1 Year Rural service under NRHM.

**1. Casual Leave (CL):** 2 &  $\frac{1}{2}$  days per month

**Authority to grant CL:** Medical Officer i/c of the health institution where he/she is posted & in his/her absence SDM&HO of the Block PHC.

**2. Maternity Leave:** Maximum 135 days (Ref. NRHM/HRD/ML/563/07-08/8020 dtd.-05/08/2008). Maternity leave will be applicable from 32 weeks of pregnancy.

**3. Special leave for appearing in the P.G. Entrance Exam:**

**Authority to grant Special Leave:** Joint Director of Health Services of the respective districts.

**No. of days:**

A) For appearing P.G. Entrance Examination for Medical College of Assam: **Maximum 10 days.**

B) For appearing in any other P.G. Entrance Examination: **Maximum 12 days in a year.**

**Admit Card of P.G. Entrance Examination along with application to Joint Director of health Services before departure for allowing to proceed to appear in the Post Graduate Examination. Photocopy of Railway Ticket/ Air Ticket of return journey shall be submitted for grant of leave.**

Any other leave without any specific Medical Ground will be treated as absence from duty without authority and incompleteness of 1 year Rural Posting and accordingly he/she will not be entitled to get the completion certificate.
