- (a) Registered APWD (Bldg) Class I-(A/ B/ C) / CPWD/ Reputed Construction Company/ Agency registered under Govt. /Public Sector undertaking
 - (b) Contractors having completed works in any one year during last five years 90% of contract value & atleast one similar nature of completed work value not less than 30% of the proposed project cost.
 - (c) In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed PHC Building works on earlier occasion.
 - (d) The contractor who was earlier allotted any NRHM works by PWD(B), Assam and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
2. Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
 3. Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam**, payable at **Guwahati**.
 4. Pre-bid meeting date and time: **25/02/2011 at 16-00 hrs.**
 5. Date for issuing of Bid Document: **24/02/2011 to 25/02/2011 during working hours.**
 6. Last date and time of submission of Bid: **03/03/2011 at 14:00 hrs at the office of the Mission Director, NRHM, Assam.**
