 - Contractors having completed works in any one year during last five years 90% of contract value & atleast one similar nature of completed work value not less than 30% of the proposed project cost.
 - In case the evaluated Bid Amounts are equal, preference for allotment of the project will be given to the bidder who has completed PHC Building works on earlier occasion.
 - The contractor who was earlier allotted any NRHM works by PWD(B), Assam and could not complete the work in all respect **in time** will not be **ELIGIBLE** to participate in the bidding process.
- Cost of tender document should be drawn in favour of **State Health Society, Assam**, payable at **Guwahati** in the form of Pay Order/Demand Draft.
- Bid security with a validity of 225 (i.e. 180+45) days should be in the form of Bank Guarantee/ FDR/CDR and drawn in favour of the **State Health Society, Assam**, payable at **Guwahati**.
