## Auction Sale Notice

It is notified for general information to all concerned that the old Transformer as detailed below is proposed to sale on auction "As is where is" basis. The interested parties are requested to submit their sealed offer on the terms & conditions furnished below:-

### **Brief Details of Transformer:-**

**(A) 11/0.43KV, 100KVA Transformer-1 No. (approx. 4years old)**

**(B) Location:-**In the campus of office of NRHM.

### **Terms & Conditions:-**

1. The items described above are lying in the office of the **Mission Director, National Rural Health Mission, Assam 16-Janapath, Khanapara, Guwahati-22** and can be inspected on any working day between 10.30hrs to 16.00 hrs upto 13-10-2011. For details, interested party may contact the Project Engineer (Electrical), NRHM.
2. The items shall be disposed off "**As is where is**" basis. The highest bid for the auctioned material will be accepted.
3. The quotationers shall be required to deposit a sum of Rs.1000.00 (Rupees One Thousand only) as Earnest Money in the form of DD/CDR with a validity 180(one hundred eighty) days from a Nationalised/ Scheduled Bank issued in favour of the **State Health Society, Assam** payable at Guwahati alongwith the quotation under the same sealed quotation. Only those quotations enclosing the earnest money as above shall be treated as valid. Quotation without EMD shall be rejected..
4. The earnest money of the unsuccessful quotationers shall be returned after finalisation of the sale process.
5. The sealed quotations should reach the office of the Mission Director, National Rural Health Mission, Assam, 16-Janapath, Khanapara, Guwahati-22 on or before **15.00 hrs. of 14-10-2011** and shall be opened on the same day at 15.30 hrs . In the event of the date of opening the quotations falls on holiday, the same shall be opened on the next working day with timing and venues as mentioned above. Interested quotationer may attend the opening of the quotation at the above date and time.
6. On payment of the full quoted value in the form of Bankers' cheque of a Nationalised/ Scheduled Bank issued in favour of the **State Health Society, Assam** payable at Guwahati, the successful quotationers shall lift the auctioned item within 7 days from the date of issue of sale order. If the quotationer fails to remove the auctioned items, he /she shall have to pay Rs.100.00 (Rupees one hundred only) per day towards watch and ward charges. After 15 days, the Addl. Mission Director, National Rural Health Mission, Assam shall be free to dispose off the material at his direction by offering to next quotationer or Re-Auction.

9. In case of failure of the successful quotationer to deposit the amount stated at para 6 above, the EMD deposited by the quotationer shall be forfeited in full.
